Road freight direct to the venue

Due to possible difficult access to the site, advance receiving facilities have been set up at the DSV Solutions warehouse. We recommend not to ship products directly to the venue without prior notice.

Please consult us on how to proceed for ground shipments that are to be unloaded/loaded directly at the exhibition site.

If your shipment exceeds 10 m³ or 2,000 kg. We will assign you a reference (time slot) and instructions for unloading/loading your goods at the fairground.

Without this reference number your goods cannot be unloaded/loaded.

For direct deliveries at trade fairs, please ask for information.

Unloading with boom trucks, cranes or special vehicles is compulsory to unload on the first official day of assembly. It is essential to request a reference (time slot) for access to the venue, in order to avoid collapses and delays in unloading.

Loading with boom trucks, cranes or special vehicles is mandatory to load on the last official dismantling day. It is essential to request a reference (time slot) for access to the venue, in order to avoid collapses and delays in loading.

Packing

All packages must be clearly marked with the name of the exhibitor, name of the event, hall, stand and our address. Please, use only strong and waterproof packaging material. Crates and cardboard boxes must be strong enough to be used after the exhibition. Packaging material must comply with ISPM15 regulations and wooden packaging must be fumigated and stamped accordingly. Fumigated containers must be decontaminated in the country of origin. Decontamination in Spanish ports causes long delivery delays and additional costs.

Permanent goods (consumables) must be packed in different packages than temporary material.

If the goods arrive with an insufficient packaging DSV will not accept any liability for hidden damage, pressure points, scratches, paint drops and any other surface damage.

Goods that are shipped with only stretch film or plastic wrap will be declared as received without packaging material.

All shipments requiring a crane, forklift over 2.5T capacity or exceeding the dimensions 200x100x200cms, please make sure to inform DSV Fairs & Events prior to your departure to the show to establish a loading date, booking of machinery and any special requirements you may need. Failure to do so may lead to delays and problems at the show.

We highly recommend sending your courier shipments to our warehouse address under CFR DSV Barcelona warehouse conditions (not DDP). This way you ensure your items arrive safely and on time. In that case DSV will arrange customs clearance; therefore, we need a complete set of documents as mentioned on shipping manual.

For shipments with special handling (boom truck. Cranes, etc.) must be onloaded on the first day of assembly and loaded on the last day of disassembly.

If you do NOT require DSV's transport and/or logistics services, but you do need to unload/load at the exhibition grounds on your own, please contact DSV so that a time slot can be assigned to you (subject to availability).
